

## 2004 FIELD LOCATIONS

**Auburn** - Game Farm Park - 3030 R ST SE Auburn, WA 98002

**Bellevue** - Hidden Valley Park - 1901 112th Ave. NE Bellevue

**NEW - Des Moines** - Steven J. Underwood Memorial Park; 21800 South 20th ; Des Moines 98198. The fields can be reached from S.216th turning onto 20th S. Entrance to the park is just beyond the post office.

**Federal Way** - Celebration Park 1111 S 324th St. Federal Way  
320th exit off I-5, Go west. Left on 11th Place So. Enter Park and Park past the fields.

**NEW - Issaquah** - Issaquah Memorial Park - 130 E SUNSET WAY Behind Sunset Way Fire Station and City admin bldg. Take **I90 EAST** take exit 18 off I 90 (East Sunset Way exit) and get on E Sunset Way. Continue for several blocks and turn right on 2nd. The field is on the left. If you are coming from Hobart Road, as you get into town turn right on E Sunset Way and then left on 2nd.

**Kent** - Memorial Field #3

**Kirkland** - Crestwood #2  
1818 Sixth St Kirkland WA 98033 - Northeast corner of 20th Ave at 108th Ave NE. Take Exit 18 off 405, go west on NE 85th - R on NE 6th St.

**Maple Valley** - Lake Wilderness Park 22500 SE 248th Street  
Maple Valley 98038

**Driving Directions:** From I-405, take the Maple Valley Hwy. exit and drive south. Follow the Maple Valley Hwy. (SR 169) approx. 11 miles to Witte Road. Turn right at the light and drive to SE 248th St. Turn left and follow SE 248th .2 miles to the sharp curve. Go ¼ mile and turn left into the park entrance. Not the Lodge entrance.

From the south, take Hwy. 18 east to the Maple Valley exit. Turn right at the light on SE 232nd and right again onto the Maple Valley Hwy (Maple Valley-Black Diamond Rd.). Take the second right onto Witte Road and follow directions above.

**Mercer Island** - 72nd Ave se and se 22nd st. Fields on the Lid. Feroglia Fields. Eastbound I-90, W. Mercer Exit., Right on E Mercer Way, Left on 24th, Left on 72nd Ave. SE. Left 1/3 mile, at end of the bridge. Parking under 72nd. 98040
